The TASC Connection

New Specialty Court Ally & Advocacy Award

During the 2019 & 2021 legislative sessions Representative Trent Ashby of House District 57 introduced legislation to provide increased, sustainable funding for specialty courts. Although efforts fell short in 2019, Representative Ashby proved to be an able ally and advocate for the mission of specialty courts and renewed relentless pursuit in 2021 of not only increased funding, but a new funding mechanism rather than underperforming collections of court costs. The result was passage of HB 1256, ultimately entitled the Judge Ruben G. Reyes Act, that was approved unanimously in each legislative chamber and signed into law by the Governor. The Judge Reyes Act dedicates 1% of Mixed Beverage Tax collections solely for Specialty Courts with a fiscal estimate of \$9.9 million for the current fiscal year, although current collections are on pace to exceed that amount.

Prior to the 2022 Annual Conference, the TASC Board of Directors unanimously approved the creation of the Specialty Court Ally and Advocacy Award to recognize an individual, community organization or group showing exceptional support of the mission of specialty courts through advocacy and activism as well as being a true ally in the furtherance and sustainability of Specialty Courts. The Board also unanimously chose to honor Representative Ashby as the first recipient due to his advocacy during the past two years.

Although Representative Ashby was only able to appear remotely to acknowledge the award at the annual conference, shown below is Judge Paul White of Lufkin, Angelina County, presenting the award in person. And in a previously unannounced decision, the award is named after Judge White in recognition of his role as Chair of the TASC Legislative Committee. Every TASC member, though, vicariously shares in this award due to the powerful influence our roles in specialty courts have made across the State that was clearly recognized by the Legislature. Congratulations to all!

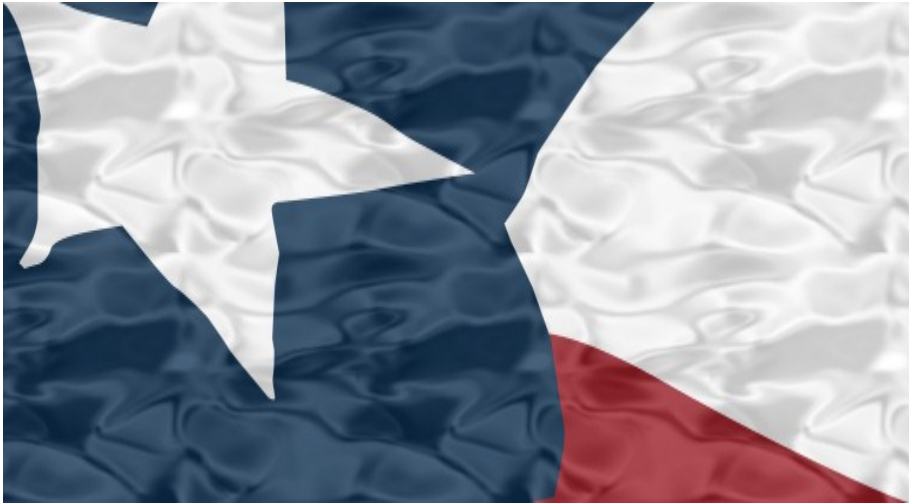

The TASC Board will gather in Denton, Texas at the Denton Embassy Suites, August 22-23, for their annual Board Member Retreat. This time is dedicated for the board to collaborate with OCA and OOG to focus on the association's goals for the upcoming year, including legislative agenda.

STAR Meets Hollywood

The National Association of Drug Court Professionals selected the Harris County STAR Drug Court Program and Houston-based Justice Forward to be featured in a documentary that reflects the Four Pillars of Recovery: health, home, purpose and community. The unique collaboration between criminal justice treatment and rehabilitation, and a non-profit service provider to address ancillary client needs, is a first of its kind in the nation, and something that other drug courts can emulate.

The film crew arrived in Houston in early June to film the quarterly STAR Drug Court graduation and interview several graduates and staff. Later that month, they returned to do special interviews with Keith Liles, STAR Program Manager, and Devon Anderson, CEO of Justice Forward as to how this relationship developed. An extensive, two-day of filming was scheduled to collect actual footage of STAR clients who received JF services. Clients were visited at their jobs, counseling appointments and at school.

The documentary was debuted as part of the closing ceremonies at the annual NADCP Conference in Nashville in late July. Representatives from Probation, STAR and Justice Forward were present.

US Congresswoman Sheila Jackson Lee Supports Funding for Specialty Courts

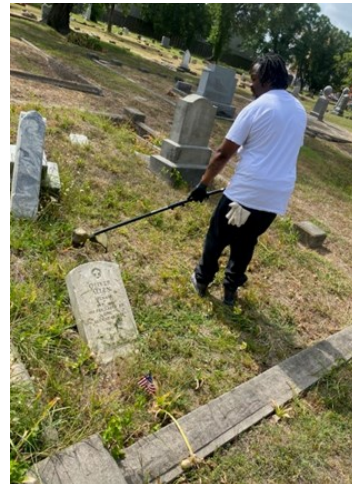
In June, STAR produced their first comprehensive graduation for all four dockets since the onset of Covid. Over 200 clients, staff, vendors and family members honored the 11 graduates and celebrated their combined 2,820 hours or 21 years of sobriety, their collective 3,300 hours of treatment, and with these new graduates, STAR proudly recognizes all 766 graduates since the program opened.

Special guest speaker was Houston's own US Congresswoman Sheila Jackson Lee who provided an encouraging message to the graduates. As the first female Ranking Member of the Judiciary Subcommittee for Crime, Terrorism,

Homeland Security, and Investigations, she leads the way on criminal justice reform. The Honorable Karen Freeman-Wilson, Chairman of the Board of Directors of the National Association of Drug Court Professionals came in from Chicago to present Jackson Lee the NADCP's "Distinguished Service Award."

STAR Alumni Community Service Project

Each STAR graduating class is asked to select a service project that they all can come together and work on for the betterment of their community. The March Class selected to provide upkeep and lawn maintenance to the Olive-wood Cemetery which was founded in 1875 as Houston's oldest African American resting grounds for slaves and later their descendants. Graduates came together in Houston's heat to mow, pull weeds and pick up trash in this often forgotten historic space, and also learned a piece of history about people who helped build the city.
