

Treatment Courts

SAMHSA is accepting applications for FY2019 Grants to Expand Substance Abuse Treatment Capacity in Adult Treatment Drug Courts and Adult Tribal Healing to Wellness Courts. The

purpose of this program is to expand substance use disorder treatment services in existing adult problem solving courts, and adult Tribal Healing to Wellness courts, which use the treatment drug court model in order to provide SUD treatment (including recovery support services, screening, assessment, case management, and program coordination) to defendants/offenders.

In November or 2018, Tarrant County launched the first in Texas, "Public Safety Employees Treatment Court Program," authorized by the recently enacted Chapter 129 of the Texas Government Code. This law authorizes a diversion program for fire, law enforcement, emergency medical responders and similar professionals who become involved in the criminal justice system.

VALOR: Collin County's Newest Treatment Program for Veterans

VALOR (Veterans Accessing Lifelong Opportunities for Rehabilitation) is a groundbreaking program that offers work opportunities and extensive treatment alternatives for felony and misdemeanor Veteran offenders who are incarcerated. This program is available for Veterans from across the State of Texas. The program is an

unprecedented collaborative effort between the North Texas Regional Veterans Court, Collin County Community Supervision and Corrections Department (CSCD) and the Collin County Sheriff's Office.

Creation of this treatmentintensive program was led by Judge John Roach of the North Texas Regional Veterans Court. "While presiding over Veterans Court I realized that there was a gap in services for Veterans who become incarcerated," Roach said. "Rather than having the Veteran just sitting there doing time, I wanted a way to provide substantive treatment for those struggling Veterans with invisible wounds. There is no doubt in my mind that the VALOR program will be a model for the Country."

DWI Treatment Court Graduation Breakfast

The Hidalgo County Felony DWI Treatment Court Program held a breakfast graduation ceremony at Costa Messa Restaurant in McAllen, Texas. The Honorable 398th District Judge Keno Vasquez presides over this program. The Felony DWI Court Program offers in-house inpatient treatment services, intensive outpatient treatment services, cognitive interventions, and recovery support services for program participants in need of services. The Hidalgo County Community Supervision and Corrections Department's Director, Arnold K. Patrick, developed the program in 2011 to reduce the recidivism rates among DWI offenders by providing intensive treatment services along with intensive supervision. The breakfast for all 52 DWI court participants was sponsored by a local non-profit community supervision improvement foundation who promotes the use of evidence-based practices in the supervision and treatment of justice-involved individuals.
