

Responsibilities of a TASC Director

The TASC Board of Directors has worked hard to reach out to all areas of the State for representation. Our efforts to diversify the culture, location, and field discipline of the Board have been intentional and deliberate; however, the struggle to fill vacancies in certain parts of the State persist. The responsibility of a Director includes monthly Zoom meetings (which are typically held over the lunch hour and last 30-45 minutes), attendance at the annual retreat (which is 2 days and typically held either at SHSU or at the location of the upcoming conference), attendance and assistance with the annual Conference (which is typically held in April), and any assignments volunteered for on any of the additional committees. Serving as a Director has minimal time commitments, and it has the benefits of collaborating with others across the State, having a voice in shaping policy and practice, and being a part of spreading awareness of Specialty Courts. Please consider submitting a Declaration of Candidacy when they are sent out for submissions. If you don't feel you are ready for a Director position, please reach out and volunteer for any of the various committees we have. You will soon see that you are every bit as qualified and ready as any of the rest of us! We can't wait to hear from you!

Region 5, 6, 7, Dallas County, and At Large Place I Director positions will be up for election next year.

TASC Legislative Committee Update

With the leadership of Judge White chairing TASC's Legislative Committee, several bills were presented at the last TASC Board Meeting for the committee to continue to monitor. Such bills are included below:

HB 541 – CSR can be converted to donations to charitable organizations.

- HB 252 – Would modify non-disclosure to expand preferential treatment currently afforded to Vet Courts to other specialty courts.

- HB 93 – Would prevent judge ordered probation for felony DWIs.

HEAT & HER in Dallas



Dallas pre-trial diversion courts AIM and DIVERT have been successfully utilizing the HEAT program facilitated by the local outpatient substance use and mental health provider, Integrated Psychotherapeutic Services (IPS), for the past two years. The Dallas County District Attorney's

Office is excited to now bring HER training to Dallas by being awarded a MAVS grant. On behalf of the Dallas County District Attorney's Office, Social Ventures Partner will accept the award during half-time at the Dallas MAVS game on February 16th.

Tarrant County Judge Charles “Chuck” Vanover Receives Two Awards

Judge Charles “Chuck” Vanover has served as County Criminal Court Judge in Tarrant County since 2015. He presides over the Tarrant County Veterans Treatment Court (VTC) and Public Safety Employees Treatment Court (PSETC).

On June 23, 2022, the Military Order of World Wars (MOWW) Ft. Worth TX Chapter 133 presented Judge Vanover with the Individual Public Service/Law & Order (PS/L&O) Exceptional Service Award and the Silver Patrick Henry Award at the June Chapter Dinner Meeting.

MOWW Chapters present the Individual Public Service/Law & Order (PS/L&O) Exceptional Service Award to those currently serving PS/L&O leaders who display exceptional leadership and management in the performance of their duties. Note: This is the first time the Fort Worth Chapter has presented this award to a deserving individual in the public service/law & order community.

The MOWW Silver Patrick Henry Award (named for the Revolutionary War patriot, Patrick Henry) may be awarded to an adult who has made significant patriotic contribu-

tions to the cause of patriotism, either within the Military Order of the World Wars or within their respective community. As Chapter Commander, Col Green is able to only present two (2) of these awards to deserving individuals annually.

Judge Vanover served a prior career in Public Safety for over 11 years as a Police Officer and Fire Fighter EMT, including being trained and serving as a SWAT team member. Also, Judge Vanover served as a prosecutor with the Tarrant County District Attorney’s Office for almost 12 years following law school.

In addition to Judge Vanover’s work as a Jurist, he also proudly served our State and Nation as a Judge Advocate for the Texas Guard.
